Wow, attendance at the November 2011 ASQ meeting was at an all-time high. There were at least 38 folks attending the dinner and 40 for the presentation. Dean Gano provided food for thought regarding traditional root cause analysis and the fact that folks are stuck in an ineffective problem solving culture. The ineffective culture stems from the fact that we hold onto several beliefs despite evidence to the contrary: 1) The existing process seems to work, 2) We believe we *are* good problem solvers, 3) It's too difficult to implement change, so solutions are never fully realized, and 4) There is a lack of a questioning attitude when defining root cause (tend to accept easy and obvious causes without delving deeply enough into the problem). I can see many of you shaking your heads in agreement here. Dean's process operates on a people-centric solution instead of a causal-based approach, and most importantly, focuses on having *evidence* for every cause defined. When there is no actual evidence, the cause is deleted so that there remains a value-based system for proposed corrective actions. If you want to learn more, go to <http://www.apollorca.com>.

Software Quality Engineering Class

ASQ Section 614 is working to determine interest in attending an ASQ sponsored Software Quality Engineering Class. This class has been offered twice in the Tri-Cities and has received positive reviews. It spans four days (7 a.m. to 4 p.m. each day) and the cost will be \$1,100 for ASQ members and \$1,400 for non-members.

This course is designed to help improve your job performance and the quality of your company’s software products. It is a broad course that addresses all of the body of knowledge area of the ASQ Certified Software Quality Engineer (CSQE). It provides a thorough introduction for those new to software quality, as well as an opportunity to fill in any “blank spots” for experienced personnel. Although not designed as a certification refresher, this course may help seasoned software quality professionals brush up on key elements of CSQE.
